

**NOTICE OF PRIMARY ELECTION
MAY 14, 2024**

Notice is hereby given that on Tuesday the 14th day of May, 2024 at the usual polling places in the election precincts of Nance County, Nebraska, a primary election will be held pursuant to Nebraska State Statute 32-802. The polls will open at 8:00 a.m. and close at 8:00 p.m. Said election will be for nominating candidates to various offices. ***Some races will not appear on the Primary Election ballot as the number of candidates filing does not exceed twice the number of vacancies; these candidates are declared nominated without opposition and advance to the November 5, 2024 General Election. Such races include the following: Fullerton City Council, Genoa City Council, Genoa Airport Authority, Central Community College District 5 and At Large, Central Platte NRD Subdistrict 9, Lower Loup NRD Subdistricts 5, District 1 Fullerton School Board, District 30 Twin River School Board, District 49 Palmer School Board, District 17 St. Edward School Board, District 60 Central Valley School Board, and District 75 Riverside Public School Board. *** Candidates shall not appear on the ballot in the primary election for the board of directors in Public Power District receiving annual gross revenue of less than forty million dollars, for board of director for Reclamation Districts, for Educational Service Unit Board, for Township Boards, and Village Trustee Board.

(Twin River Public Schools Bond)**
"Shall Nance County School District 0030 (Twin River Public Schools) in the State of Nebraska issue its bonds in a total principal amount not to exceed \$39,900,000 for the purposes of financing the costs of (a) constructing one or more additions to the District's existing K-12 school buildings and related site improvements, (b) demolishing portions of an existing building, and (c) purchasing certain necessary equipment, furniture and apparatus for such buildings and additions; said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rates, to become due at such times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and "Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?"
