Public hearing for the purpose of adopting revisions to Nance County's Rules for the Administration of General Assistance. No public present, Discussion held.

**RESOLUTION #25-1**

WHEREAS, pursuant to Neb. Rev. Stat. 68-132, it is the duty of the county board of each county to provide general assistance to all poor persons who are eligible; and,

WHEREAS, pursuant to Neb. Rev. Stat. 68-133, all counties are required to adopt written standards of eligibility and assistance for general assistance to poor persons; and,

WHEREAS, pursuant to Neb. Rev. Stat. 68-134, all counties must review their standards on a biennial basis to ensure that such standards reflect changes in living standards and cost-of-living,

NOW, THEREFORE, BE IT RESOLVED by the Supervisors of Nance County that Nance County Resolution #23-2 known as the Rules for the Administration of General Assistance approved and adopted on January 24<sup>th</sup>, 2023 hereby be repealed; and,

BE IT FURTHER RESOLVED by the Supervisors of Nance County that the Rules for the Administration of General Assistance, updated in January 2025, fulfill the county's obligations to poor people as set out by law and are hereby adopted. Moved by Nelson and seconded by Crouse to approve said resolution.

Steve Pritchard, Lead Educator Extension Boone-Nance Counties, presented to the Board the Boone-Nance Extension Annual Report. Which includes 1) Summary of 2023-2024 budget expenditures, 2) Current fiscal year 2024-2025 budget, 3) County Impact Report, 4) Program impacts and accomplishments for each educator and assistant/associate, 5) Individual Impact Statements, and 6) Samples of 4-H newsletters, major program brochures and other products that represent 2024 programming. Josie Crouch, Livestock Systems Educator, presented a summary of her major accomplishments for 2024 as a new Extension professional. Pritchard presented the 2024 Event Building Rental summary.

Tony Bernt, Highway Superintendent, gave updates on the road department. Have a meeting with FEMA/NEMA on Friday for the 2024 Flood work. Continuing regular maintenance, tree shredding and shop maintenance. 1 tree shredder down as wheeled excavator is waiting on part for repair. The two new pickups for the road department were picked up, working on getting everything installed on them.

**Resolution 25-2.** Certificate of Completion- Statewide Upgrading Existing Stop Sign Location of Rural Roads. Resolution stating the project # HSIP-STWD(203) is properly completed.
