The real property must have damage in excess of 20% to be considered. The form is new and information on the form will be in both the Nance County Journal and Genoa Leader-Times this week. Zoucha gave one example: One 40-acre tract of land was valued at 21 acres of irrigated and 19 acres of grass. If the whole 40 acres are changed to waste land @ \$315.00/acre the value of the 40-acre tract goes from \$130,050.00 to \$12,600.00. Any decrease in land value will be for the current year only.
