Will be keeping one tree shredder running to try to stay ahead of tree shredding, Weed Superintendent is continuing to spray the areas that are shredded.

Brett Houtby present with road concerns. He voiced concerns of 110<sup>th</sup> and 485<sup>th</sup>. Concerns with ditches needing dug out, road widths, culverts needing to be looked at and washouts. Bernt stated that they are continuing to get road projects fixed and that they appreciate being told of any new issues that they can look into and get put on a list.
