A meeting of the County Board of Supervisors of Nance County, Nebraska was convened in open session on July 22nd, 2025 in the Supervisor's Room, Nance County Courthouse, Fullerton, Nebraska.

District 5 Probation Carrie Rodriguez, Chief Probation Officer, and Morgan Campbell, Chief Deputy Probation Officer, presented their probation services and budget report. Presented the services provided last year to Nance County. In 2024 45 adults and 12 juveniles were

serviced. Total voucher amount for 2024 for adults was \$16,013.00 and juveniles \$92,062.43. 761 drug tests were collected in Nance County in 2024. Nance County budget for probation increased from \$5,298.18 to \$5,342.11.

Riley Lane from the Nance County Ag Society presented estimates to repair drainage issues at the fairgrounds. Estimate from RT Plumbing for \$32,000 (\$22,000 Ag Society portion and \$10,000 County portion). Estimate from Thiessen Welding and Irrigation for \$27,276.50 (\$15,312.50 for Ag Society portion and \$11,964.00 for County portion). Discussion held. Discussion on having city clean out ditch on the west side of North Ida Street, north to the next intersection and having culverts placed at the driveways to the arena in the ditch. Would like work to start this fall, would like both the ag society and county portions to be done at the same time. Lane stated that he will take these estimates to the next Ag Society meeting for a vote on who they will go with to do the repairs.

Sheriff Ben Bakewell presented an application for a Swift Water Rescue Team that will be headed by the Nance County Sheriff's Department. He is working with local fire, rescue and sheriff deputies to build the team. He needs 15-20 members and currently has 7-8 applicants. In Nance County we have 2 rivers, the Canal and Beaver Creek that all have swift moving water. Will work on fund raisers to help with cost of trainings, etc.

The board reviewed the treasurer's semi-annual statement for January 1st, 2025 through June 30th, 2025. Moved by Nelson and seconded by Crouse to approve the Treasurer's semi-annual statement – January 1st, 2025 through June 30th, 2025.

Cody Kutschkau, Road Foreman gave updates on the road department. Tony Bernt will work with City on ditch drainage on the west side of N Ida Street by Fairgrounds. The 2018 Dodge with utility box is in the shop, not sure on cost of repair yet. Bridges on 120th and Valley Road are both open. Working on hauling gravel. Working on washouts, bridge walls and FEMA projects from 2024 Flood. Representative from Husker Steel present thanked Nance County for choosing them to assist with the 2 new bridges that have just been completed. Husker Steel thanked Nance County Road Department for the assistance they provided when needed. Cornwell stated he was happy with the turnaround on the bridges from Norfolk Contracting.

Landowner Easement for Jim Crouse/filled out by Don Grant. Don Grant will be doing the work. It is for an electrical line across Nickel Road to their barn (19818 N. Nickel Road). Discussion held. Moved by Nelson and seconded by Voichoskie to approve above easement.

Township Road Maintenance Agreements brought to the board. Discussion was held on pricing on hourly rate per machine for additional work requested by the township and pricing per mile for road maintenance done by Nance County. After discussion, moved by Nelson and seconded by Russell to change per hour for additional work to \$175/hour and increase per mile of road maintenance for minimum maintenance roads by 30% and for regular roads by 20%. Discussion held, would like to make even amounts. Nelson amended his motion to additional work to \$175/hr and minimum road maintenance to \$600/mile and regular road maintenance to \$1025/mile, seconded by Russell.

SuAnn Engel present to discuss budget updates. Will be looking at needing a Joint Public Hearing. Discussion held. Presented summary of changes made to budget from last meeting, highlights of the budget, purposed transfers and presented Authority Computation form.

Moved by Horacek and seconded by Nelson to adjourn the meeting.
