The Board reviewed and approved the County Treasurer's Miscellaneous Receipts #250090001 through #25090055 in the amount of \$188,206.11 for the month of September, 2025. Moved by Russell and seconded by Voichoskie to approve Treasurer's Miscellaneous Receipts.

Resolution #25-20

Be it Resolved by the Nance County Board of Supervisors to authorize the Nance County Treasurer to make the following transfers in accordance with the adopted 2025-2026 budget: transfer \$225,000 from General to Road Fund, \$150,000 from General to Sinking Road Equipment Fund. Moved by Ditter and seconded by Russell to approve Resolution #25-20.

Discussion of the Countywide Cost Allocation Plan and Certification Statement. WJE Consulting performs the cost allocation for District Court and Child Support Enforcement. They find all the indirect cost computations for District Court and Child Support Enforcement in the Nance County Courthouse. Lisa Lassek, in the County Attorney's office files a quarterly report to DHHS for reimbursement of the cost for Child Support Enforcement and Aaron Benson, Clerk of District Court files a quarterly report to DHHS for reimbursement of cost for District Court. After discussion, Nelson and seconded by Crouse to approve signing Cost Allocation Agreement.

Discussion held on a lean-to or other options for storage of the 2 sheriff vehicles (LAV and drone vehicle). Would like the storage option to be climate controlled and secure. Options discussed and will look more into them and hopefully bring numbers and ideas to the next board meeting.

Discussion of N 468th on the east side of Belgrade. An invoice was presented to the county; Invoice is made out to the Village of Belgrade. Discussion was held and decided county is not responsible for the invoice. Reminder that any work to Road or Right-of-way needs to be done by county. County has this drainage issue on their project list.

Tony Bernt, Highway Superintendent, gave updates on the road department. Continuing to shred trees. Continuing to work on project, will be starting on ditch project on S 270th. Have a few guard rails to replace. Road building remodel scheduled to start November 3rd. 2 new employees will start on November 3rd. Moving offices to the mobile office this week.

Discussion of trading or selling motor grader on auction site, as new motor grader set to be delivered in December. After discussion, there were 6 votes to advertise the motor grader on the auction website.

The State of Nebraska Statutes require each county to annually certify the appointment of the County Highway Superintendent to the NDOT by Dec. 31st of each year in order for a county to qualify for the annual Incentive Payment by using the Year-End Certification of County Highway Superintendent form; **Resolution #25-21** authorizing County Board Chairperson to sign the Year-End Certification of County Highway Superintendent form is presented. Moved by

Nelson and seconded by Crouse to adopt said resolution. The full resolution is available for inspection at the Nance County Clerk's Office during normal business hours.

Moved by Horacek and seconded by Ditter to adjourn the meeting.
