A meeting of the County Board of Supervisors of Nance County, Nebraska was convened in open session on November 10th, 2025 in the Supervisor's Room, Nance County Courthouse, Fullerton, Nebraska.

Chairman called the meeting to order at 9:00 am with the following members present-Timothy Cornwell, Robert Voichoskie, Ralph Horacek, Steve Crouse, Darren Nelson and Scott Russell. Absent- Andrew Ditter. Also, present is County Clerk, Adrian Chlopek and County Attorney, Rod Wetovick.

Chairman advised those present of the open meetings act and its posting in the Supervisor's Room.

Moved by Voichoskie and seconded by Russell to approve minutes of the October 28th, 2025 meeting.

Moved by Horacek and seconded by Crouse to approve all claims submitted.

The Board reviewed and approved the Monthly Fee reports of the County Clerk in the amount of \$1,658.96; Clerk of the District Court in the amount of \$346.32 and County Sheriff in the amount of \$1,465.09.

Certification letter from Nance County Treasurer, certifying that 25 Distress Warrants in the amount of \$18,530.58 were delivered to the County Sheriff on October 29th, 2025. Moved by Russell and seconded by Crouse that the above was reviewed and approved.

Josie Crouch, the Beef Educator with the Extension Office, presented information about water program via zoom. She would like to get information to the community on what people should look for, test for, how to treat if needed and health repercussions this would be for humans and livestock. This would allow the community to make informed decisions. She talked about doing something in the evening, and she will be setting up a date soon. Will be looking to work with the NRD for resources and grant opportunities. Noted that Randy Zmek and 2 gentlemen from the Lower Loup NRD were in attendance. Lower Loup NRD stated they would be glad to participate. Randy Zmek made general comments and passed out a handout on what work he has done and flyers from the extension office on protecting Nebraska's water, ensuring safe drinking water and what to test for.

Tony Bernt, Highway superintendent, gives department updates. Road building remodel started today with demo. Continuing to shred trees, currently out on 110th. Slowing down on gravel hauling. Project on S 270th is complete. Motor Grader is listed on Big Iron, auction will start in early December, will be open for a week. Weed Superintendent sprayed the volunteer trees under the bridges. Received the last payment for the 2019 Flood that project is now closed out. Have received the first payment for the 2024 Flash Flood.

Chairman opened the bids received for the lowboy and pup trailer. 3 companies submitted bids, there was 1 bid for the pup trailer and 3 bids for the lowboy trailer. RDO Truck Centers: Lowboy bid was \$114,894 and pup trailer was \$68,807.09. Kaufman Trailers, LLC: Lowboy bid was \$69,250.00. Globe Trailers: Lowboy bid was \$95,095.63. RDO Truck Centers was present during opening. Discussion held. Moved by Nelson and seconded by Crouse to purchase pup trailer from RDO Truck Centers for \$68,807.09. Moved by Nelson and seconded by Crouse to purchase lowboy trailer from Kaufman Trailers.

Moved by Horacek and seconded by Nelson to adjourn.
