A meeting of the County Board of Supervisors of Nance County, Nebraska was convened in open session on December 9th, 2025 in the Supervisor's Room, Nance County Courthouse, Fullerton, Nebraska.

Chairman called the meeting to order at 9:00 am with the following members present- Andrew Ditter, Robert Voichoskie, Ralph Horacek, Steve Crouse, and Scott Russell. Absent- Timothy Cornwell and Darren Nelson. Also, present is County Clerk, Adrian Chlopek.

BE IT RESOLVED BY THE NANCE COUNTY BOARD OF SUPERVISORS that the applications for designation as official Nance County depositories for 2026 from Points West Community Bank, Fullerton, NE; First Bank & Trust of Fullerton, Fullerton, NE, Genoa Community Bank, Genoa, NE, Nebraska Public Agency Investment Trust (NPAIT), and Union Bank & Trust of Lincoln, NE, indicating sufficient pledged collateral to Nance County be approved.

BE IT FURTHER RESOLVED BY THE NANCE COUNTY BOARD OF SUPERVISORS to authorize the Nance County Treasurer to invest county monies in the approved depositories for 2026.

Letter received from Northeast Nebraska Area Agency on Aging needing a letter of appointment for the nomination of Cathy Hill-Klein to represent Nance County on the Advisory Board for a three-year term. In the 22-county service area, the senior center(s) in the county nominate a person to represent them on the Advisory Board. Discussion held. Moved by Horacek and seconded by Crouse to approving signing a letter of appointment to the Advisory Board.

Tony Bernt, Highway superintendent, gives department updates. Road Building remodel continues. Working on a FEMA site. Still working on shredding trees. Have purchased a blade and a salt spreader for the UTV. This will allow for just 2 people to do snow removal at the courthouse, 1 in the UTV and 1 in the Skid loader. The ramp out front has been placed back after have a rubber grip coating placed on it.
